

Instructions for Chinese Government Scholarship Information System (CGSIS, for Applicants)

Please carefully read the instructions before applying for the scholarship.

Step 1: Visit "CSC Study in China" website, and click "Scholarship Application for Students" at <http://www.campuschina.org>.

Register an account through [CREATE AN ACCOUNT] and log in with your account.

Step 2: Input Personal Details. Click "Edit Personal Details" and finish imputing personal details by filling all the information, verifying and saving the information. After the completion of this section, return to the previous page by clicking "Finish" and start filling in your application information.

Step 3: Select the Correct "Program Category".

Please select Program Category "**Type A**".

Step 4: Input the Correct Agency Number.

Your Agency Number is: **8071**.

Program Category and Agency Number are directly matched, both are mandatory for online application.

After inputting the agency number, the matched agency name will automatically display on the page. As Program Category and Agency Number are directly matched, application processing authorities will not receive your online application if the program category or agency number are not correct.

Step 5: Input Application Information

Next, please move to the section of "Language Proficiency and Study Plan", and upload "supporting documents" as requested, then click "Submit" to complete the application. Carefully check each part of your application before submission. Ensure all information and uploaded documents are valid and accurate.

When applicants of "Type A" select "Preferences of Institutes", the system will automatically match available universities based on the selected "Student Category and Preferred Teaching Language".

The "Catalog of Discipline Field, First-level Discipline, Specialty" is available in the "Help" section. Applicants could download the file to clarify the relationship between Disciplines and Majors.

Step 6: Once submitted, no amendments can be made to "Personal Details" and "Application Information". Before the application is processed by the authorities, applicants can revoke the submitted application by clicking "Withdraw" and edit it. After revoking, applicants must resubmit the application after re-editing; otherwise, the application will not be processed. Once the application is processed, it cannot be revoked.

Step 7: Click "Print the Application Form" and download the form.

Step 8: Submit the scholarship application in accordance with the requirements of the dispatching authorities (or application processing agency).

The China Scholarship Council (CSC) has never entrusted any individual or intermediary agent to handle Chinese Government Scholarship applications. All applicants are reminded to submit applications directly through official dispatching authorities to avoid fraud. The following is the only official website for the CSC to release Study in China information: <http://www.campuschina.org>. Do not trust information from other portals or sources.

NOTES: Applications with incorrect Agency Numbers will not be processed.

Please use Firefox or Internet Explorer (11.0) for operation.

For applicants using Internet Explorer, please close the "Compatible View Mode" function before editing.

All application information must be filled in Chinese or English.
