Further details on the exam and its organisation will be provided during the training.

Up to 16 candidates will be selected among applicants from the different invited countries. The selection will be made by the House of Training and its experts, according to the relevance of the participants' profiles (which will have to correspond to the programme target audience) and motivations. The participants are requested to have a **sound knowledge of English**. The selected candidates will have to be equipped with well-functioning microphones and **webcams**.
