"Cloud" and "Outsourcing" can easily become nightmare words in an organisation if there is not a professional who manages, supervises, and governs the cloud computing environment and its operations. The cloud officer allows an organization to harness the power, productivity, and efficiency from a suite of cloud computing solutions and services. As such, the cloud officer is the ultimate custodian of cloud-related resources and components.

The Cloud Officer's primary responsibility is to ensure that an organization gets the most out of cloud computing without jeopardizing the business. The cloud officer leads the cloud adoption/migration from the very beginning phase of cloud needs assessments, vendor evaluation and short listing, down to deployment, maintenance, and troubleshooting. The CCO's job has two main components: to align cloud solutions with business objectives and goals, and to oversee cloud operations from a technical standpoint. However, because cloud computing is largely a third-party managed solution, the CCO's key job roles also include the evaluation, design and implementation of stringent cloud security and governance measures. #### **Examination**

Examination ONSITE on Friday 20<sup>th</sup> June from 18.00 to 20.00 based on a MCQ questionnaire of around 50 questions. The required passing rate is 80%.

Participants who will successfully complete the examination will receive the certificate of completion co-signed by the Luxembourg Bankers' Association (ABBL).

## How to apply?

Interested candidates may apply for this programme by filling in the attached application form. We are inviting the candidates to send their applications to the House of Training-ATTF partner in their country (from whom they received the present invitation) <a href="https://www.attf.lu/partners">https://www.attf.lu/partners</a> by May 9<sup>th</sup>, 2025.

<u>If you are selected</u>, the House of Training-ATTF will inform its partner in your country latest on <u>May 16<sup>th</sup>, 2025</u>. You will then receive the confirmation documents.

#### **Selection Process**

<u>Only complete applications will be retained</u>. Candidates with the most relevant profiles in reference to the target group and with pertinent motivations are most likely to be selected.

The seminar and the exam will be conducted in English without any translation. Therefore, a very good knowledge of English is essential to ensure all participants maximise their benefit from the course and enhance the chances to succeed in the exam.

Candidates who successfully complete the examination will receive the certificate of completion co-signed by the Luxembourg Banker's Association ABBL: "Certified Cloud Officer & Outsourcing Officer". This will certainly be a fantastic asset for their career!
